Be sure to keep your own copies because none of this will be returned to you. At the time I notify the winner, I'll send the mail address of where you'll need to mail it.

*Tip:* keep in mind that all folks need to be wearing modest clothing, portray a godly standard—and be having fun!

*Your First Step to Enter:* email a copy of the photo in .jpg format as an attachment to Where @RebeccaOndov.com (be sure to remove the space from the email before sending this). In the subject line of the email type "Where in the World" and in the email please let us know the location of where the picture was taken (i.e. my barn, Hamilton, MT), who you are, and who is in the photo.

*Then* if your photo is chosen I'll email you with your next step.
